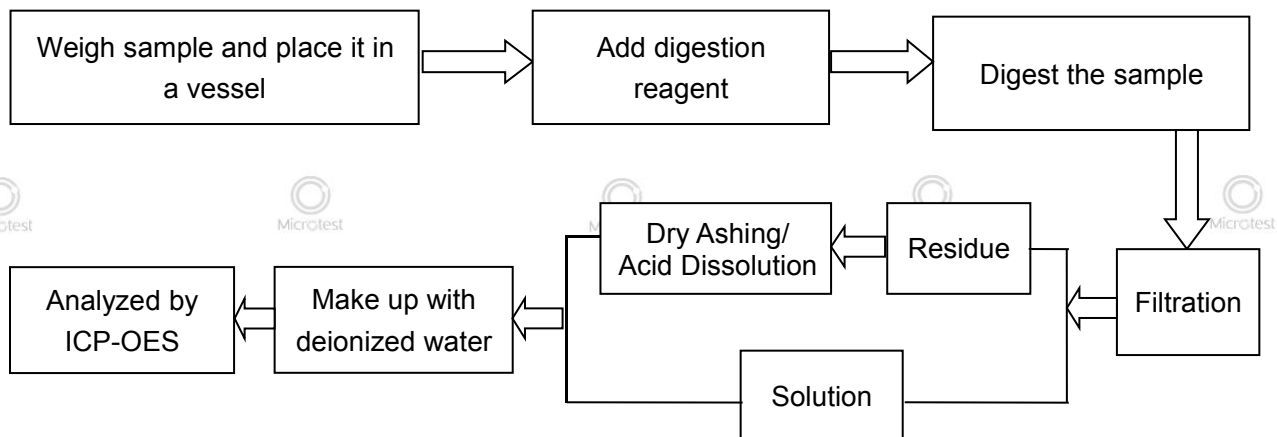

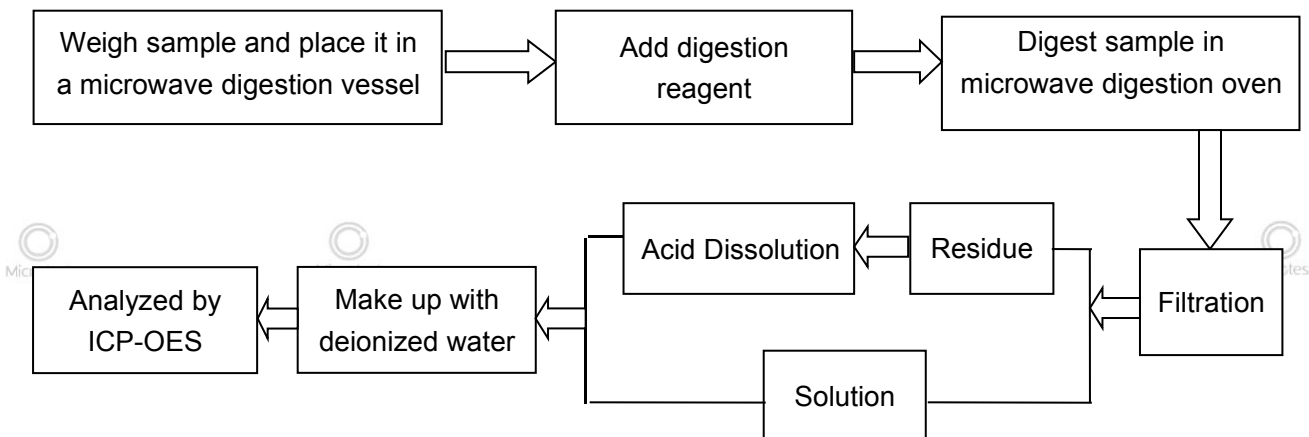

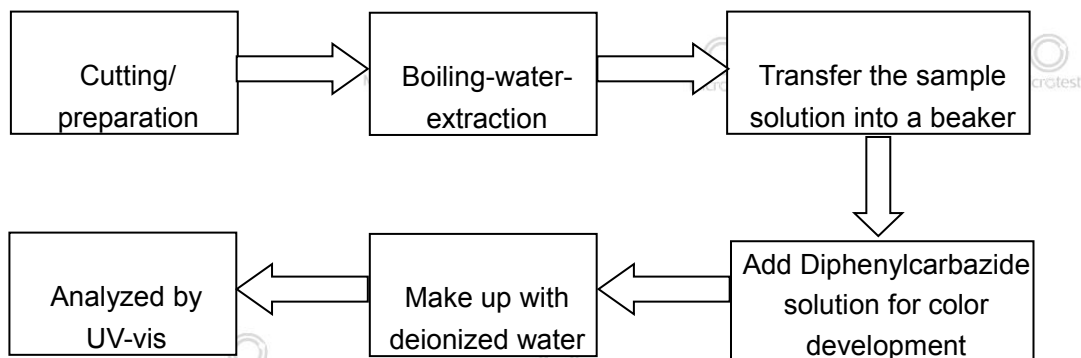
1. Lead, Cadmium



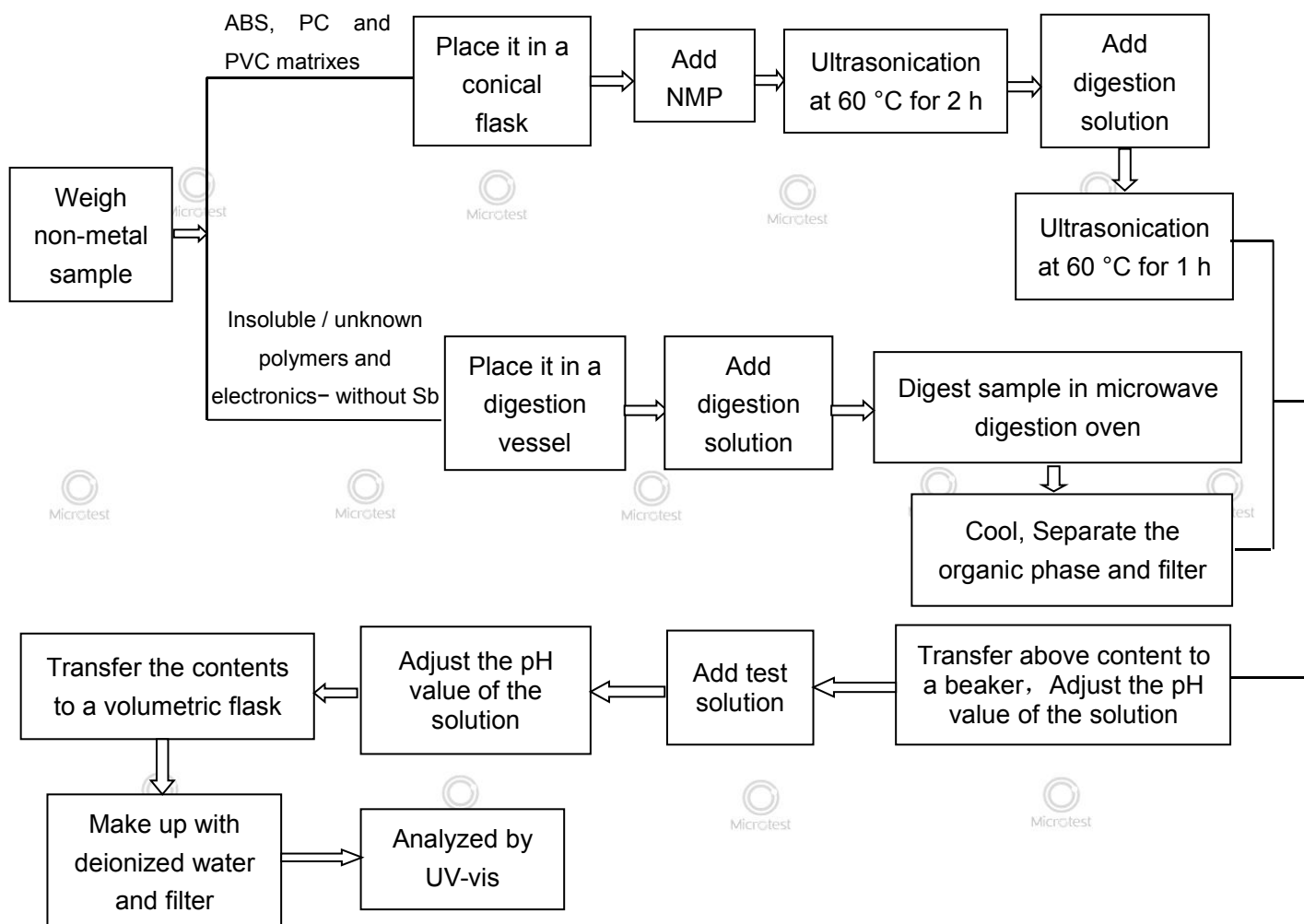
2. Mercury



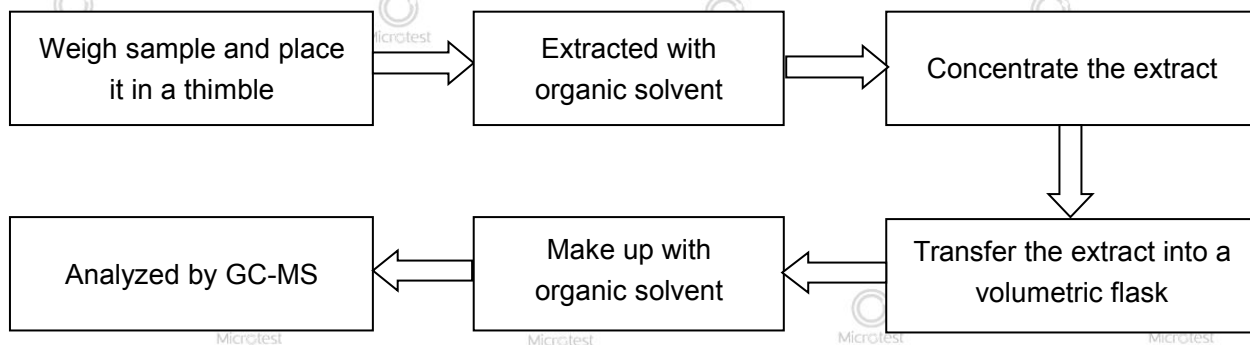
3. Hexavalent Chromium (For metal material)



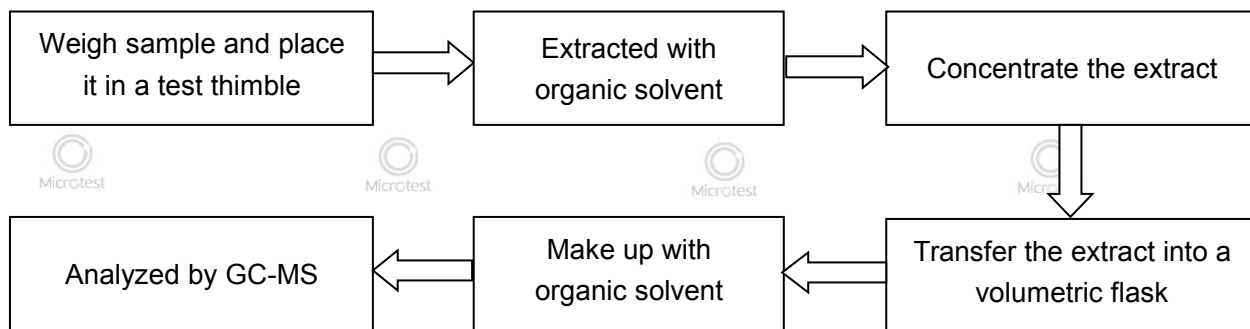
4. Hexavalent Chromium(For non-metal material):



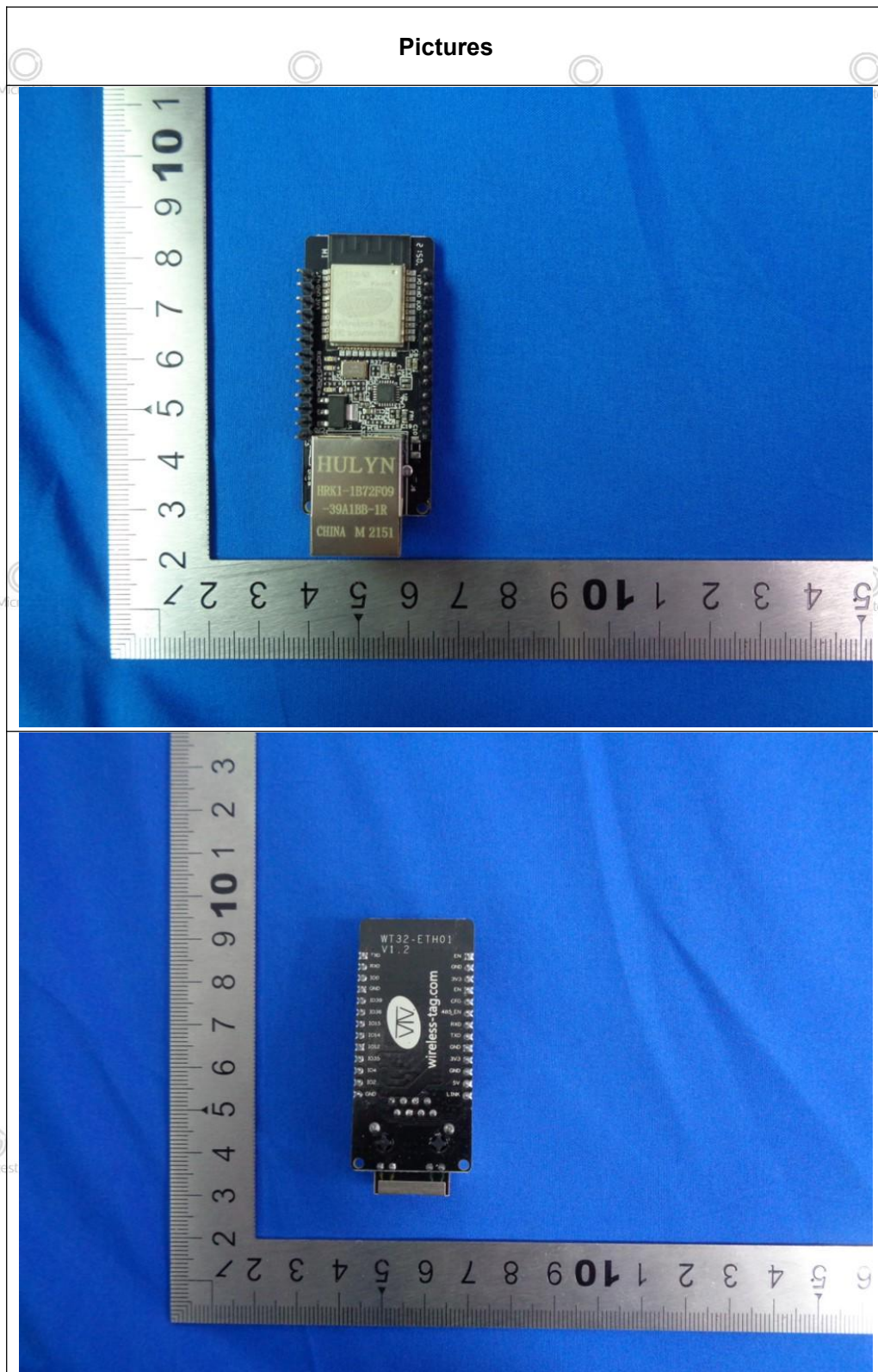
5. Polybromobiphenyls (PBBs), Polybromodiphenyl ethers (PBDEs)



6. Phthalates(DBP, BBP, DEHP, DIBP)

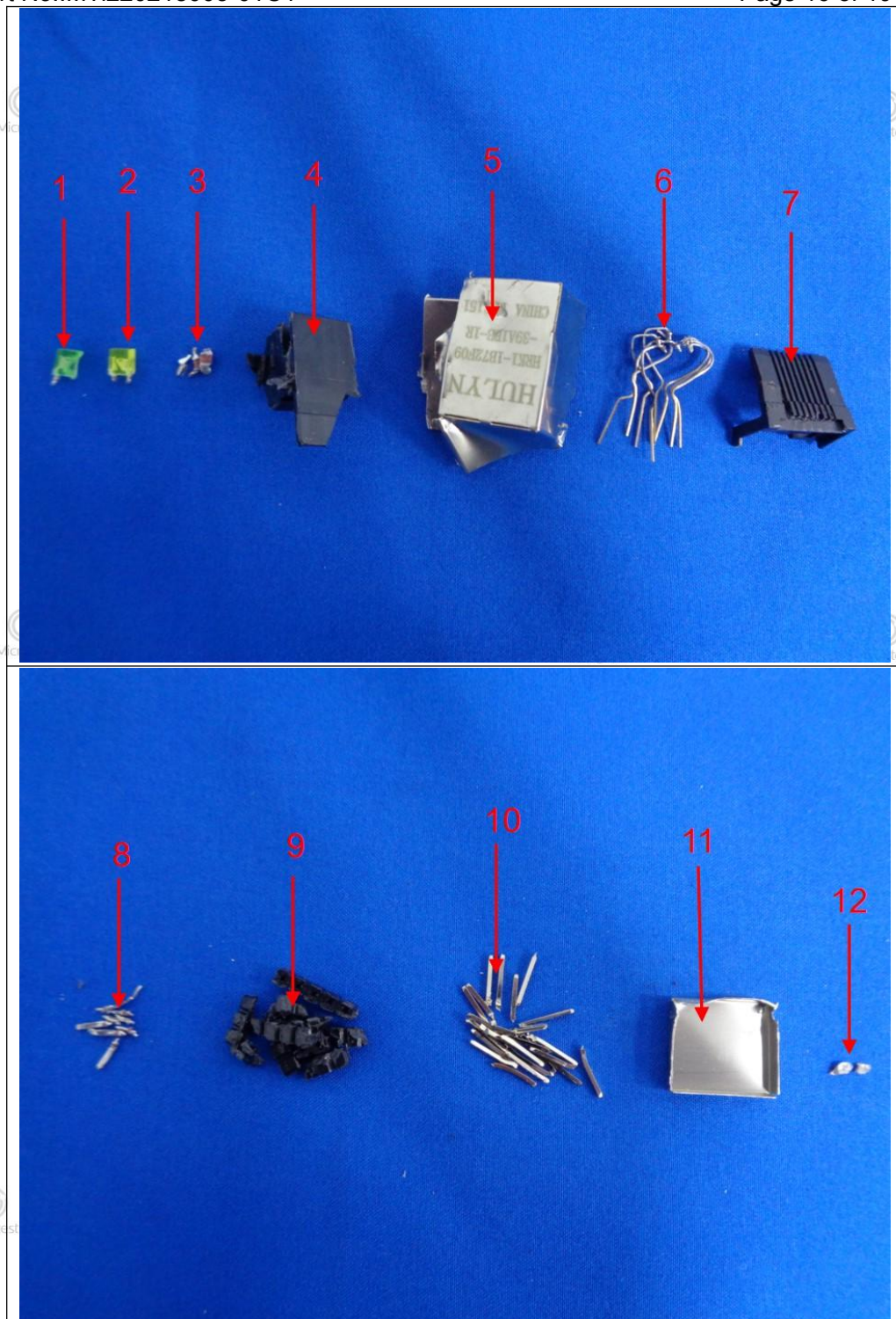


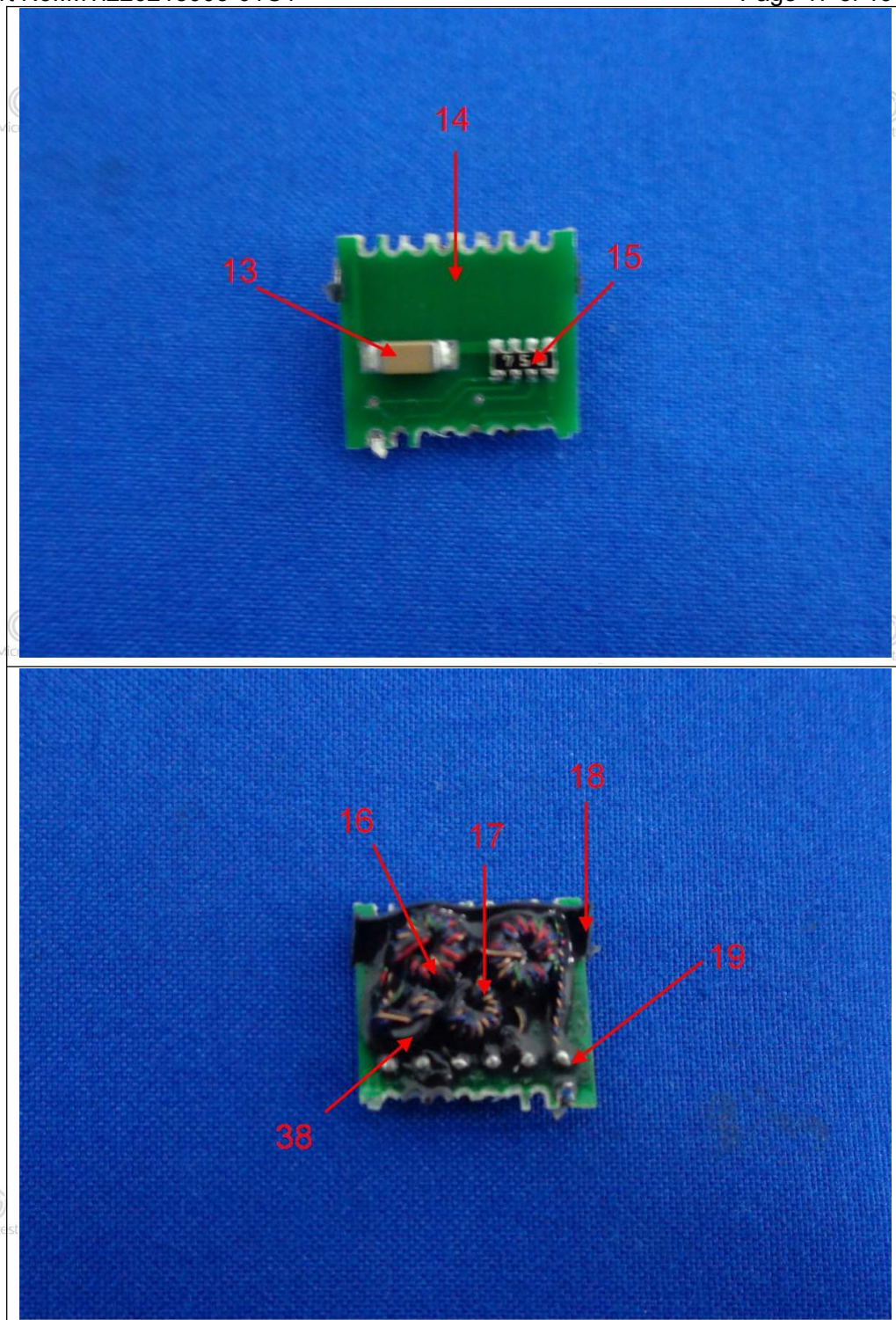
