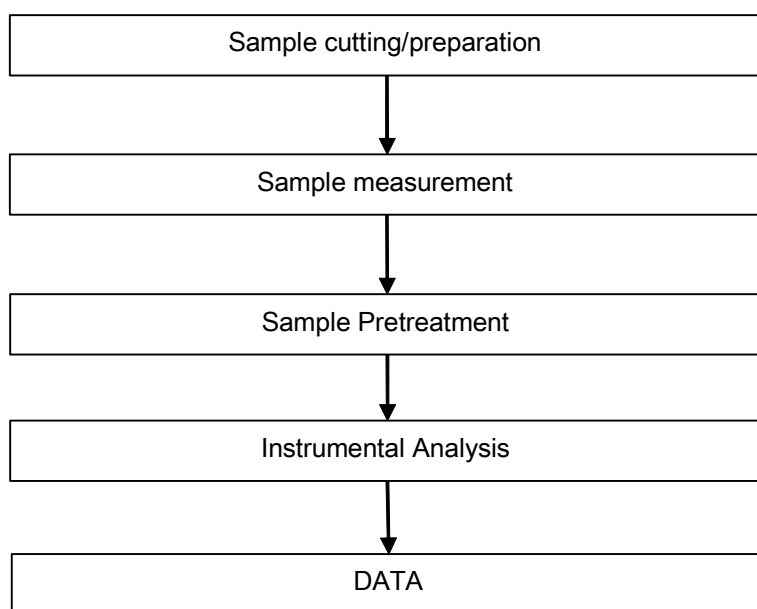

SVHC Testing Flow Chart



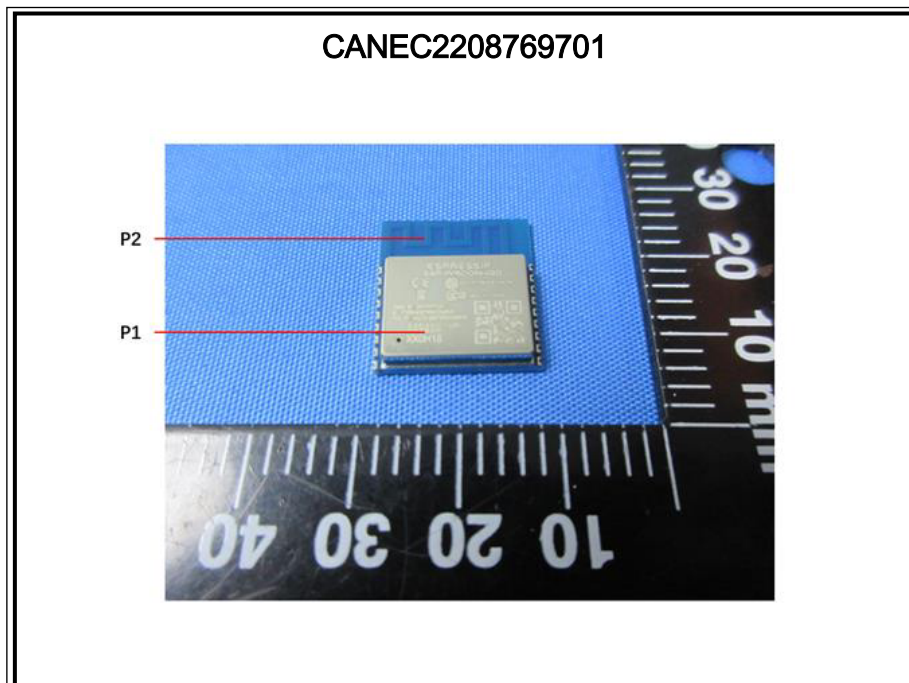
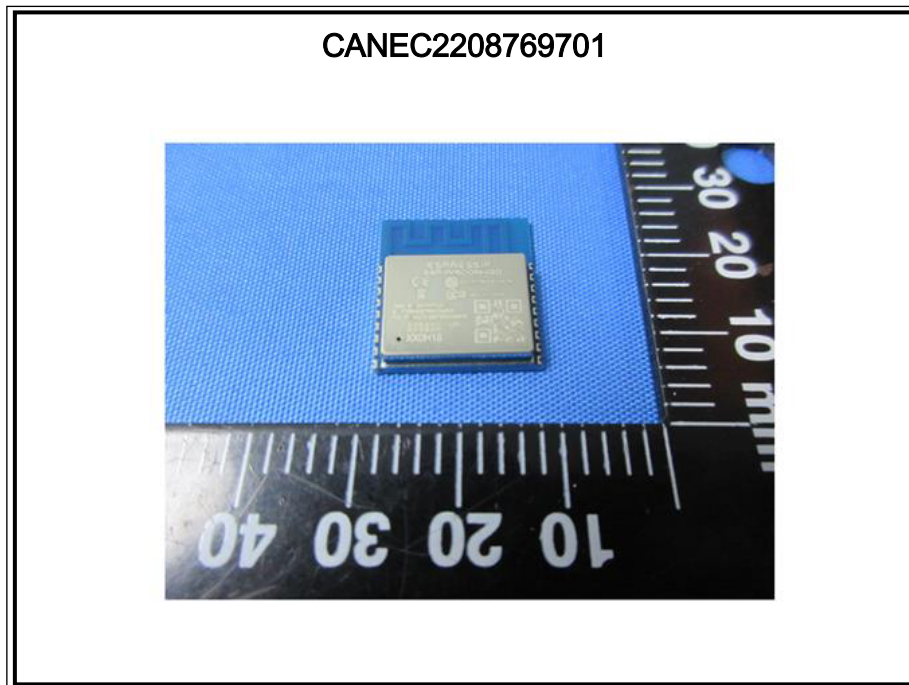

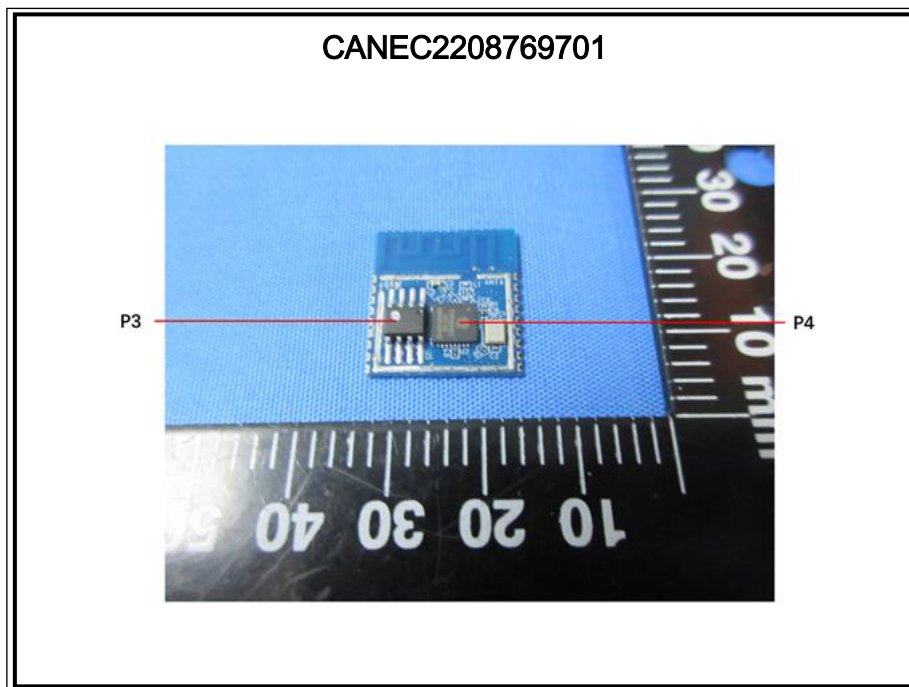
